## Silvana Malle

Congratulations to Silvana Malle, who in October was appointed Professor Emeritus at the University of Verona.



Silvana's last appointment was as Director of the Centre for East-West Studies and European Integration and Professor of Economic Policy at the University of Verona. She was previously Head of the Non-Member Economies Division at the OECD Economics Department, where she directed and supervised economic analysis and surveys of Central and Eastern European countries, Russian Federation, Brazil, Chile, and China. While she initially focused on transition economies, drafting reports for the Secretariat and contributing to the forecasting rounds for the preparation of the OECD Economic Outlook, she later increasingly developed research and cross-country analysis on emerging market economies in Asia and South America.
